

## **FNCE 2010 Course Substitution**

*effective Fall 2023*

A finance student may elect to substitute FNCE 2010 with another FNCE course if the student meets one of the following conditions:

- has a course grade of B or better in MATH 1300 or APPM 1350 (Calculus 1)
- has a course grade of B or better in a course taken at another institution that counts as CU credit for MATH 1300 or APPM 1350
- has a score of 4 or better on the AP Calculus AB exam OR the AB sub-portion of the AP Calculus BC exam
- has a score of 7 on the IB Mathematics: Analysis and Approaches (Higher Level only)

If a student chooses to apply the FNCE 2010 substitution, they will need to substitute in another FNCE course (or Master of Finance course subject to instructor approval) to fulfill the credit requirements of the FNCE area of emphasis. The calculus credit will not replace the credit for FNCE 2010.
